Dear Sir,

The Tahiti Cycling Federation and its 26th Organizing Committee, hereby, send you this invitation to participate in the international event « Tour Tahiti Nui » to be held in French Polynesia from October 30th thru November 05th, 2022. We will be honored to welcome your team to our stage road race on the islands of Tahiti and Moorea in the aforementioned days.

The official registration form which will be sent to you in the beginning of the month of April will need to be returned to the federation by mail at [ftcyclismes@gmail.com](mailto:ftcyclismes@gmail.com) no later than **September 30th, 2022 at 11 am (local time)** along with a non-refundable (but deductible from the overall team's fees) deposit of 20% of the commitment fees to be wired on the following bank account:

Other than the roundtrip flight transportation at your delegation's charge, the participation conditions hereafter apply.

**UCI licences and medical insurance, driver's licence To be officially in the 2022 "Tour Tahiti Nui" and "Tour des Vahine" :**

1. All engaged riders of the 2022 Tour **must be over 18 years-old** and a holder of an UCI international licence. UCI requirements state that appropriate medical international insurance must accompany the purchase of an international Licence. According to UCI Cycling Regulations relating to international licences and insurance (1.1.022) appropriate insurance should include:

*“Insurance for bodily injury (in and out-patient hospital expenses and medical care, transport costs, permanent disablement, death) and material damages (loss of earnings) in case of accident on the occasion of a cycling competition or during training”. All engaged riders of the 2022 Tour must provide a copy of both documents to the Organizing committee: The Valid UCI International Licence and the valid appropriate insurance along with Registration form.*

2. An International Technical License is required for all team staff (coaches, managers, mechanics and/or soigneurs) attending the event. A copy of the International Technical License along the valid appropriate medical insurance must be produced to the Organizing committee along with the Registration form. If the team staff is to be an official driver (van, scooter) of the caravan, he/she must be a holder of an international valid driving license. The Organizing committee will require a copy of the document along with Registration Form.

### **Airfare**

The organizing committee will take at its charge:

- 1 return ticket for a complete team departing from Paris or LAX;
- 2 returns tickets for a complete team departing from Pacific countries such as New Caledonia, New Zealand, Australia etc.

### **Fees applying to the engaged rider:**

Rider engagement fee is set at 212 \$NZ (per rider).

Rider engagement by stage at 56 \$NZ(per stage)\*.

IJSPF accommodation\*/ IJSPF catered meals/ Gas/ Ferry boat transfers fees are set at 559 \$NZ (per rider).

A total fee per rider is: 212 \$NZ + 559 \$NZ = 771 \$NZ.

However, the Organizing Committee will take at its charge 50% of the total fee per rider (in 2022) which total will then be: 771 \$NZ – 385.5 \$NZ = **385.5 \$NZ due (per rider in 2022).**

### **Fees applying to the technical staff (2 technical staff maximum per team)**

The participating fee of the technical staff includes: IJSPF accommodation\*/ IJSPF catered meals/ Gas/ Ferry boat transfers fees are set at 658 \$NZ (per staff).

However, the Organizing Committee will take at its charge 50% of the total fee per staff (in 2022) which total will then be: 658 \$NZ – 329 \$NZ = **329 \$NZ due (per staff in 2022).**

A non-refundable deposit\*\* of **462.6 \$NZ** (deductible from your total team’s fees) is to be wired on the bank account stated above **before the dateline of September 30th, 2022** or as soon as the team confirms its engagement to the event.

Example, if your team is composed of 4 riders and 2 technical staffs, that is 385.5 \$NZ x 4 = 1 542 \$NZ; 329 \$NZ x 2 = 771 \$NZ; that is 1 542 \$NZ + 771 \$NZ = 2 313 \$NZ; a total of 2 313 \$NZ x 20% = **462.6 \$NZ.**

### **Team’s composition**

Under the conditions set out above, the team will be made up of four (3) minimum riders and four (4) maximums.

The team can have a maximum of 2 technical staffs (coaches, managers, mechanics and/or masseur).

### **Insurance**

In the event of a health or other problem that arises during the competition, foreign teams or riders are requested to take out travel insurance cover called “Assistance Rapatriement”.

### **Regulations modifications**

To conform to the regulation of an UCI event, the federation which aspires to register the Tour Tahiti Nui, modification is being brought to the regulation of the Tour and they will be communicated with you later on.
